

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favour of the following officials who will be travelling to Kolkata, India on the 8<sup>th</sup> of April, 2017 by the 2<sup>nd</sup> Maitree Express, in its trial run of Khulna-Benapole-Kolkata route. The train is likely to commence from Khulna at 08:00 am and reach Benapole at 10:00 am. After the inaugural ceremony at Benapole Railway Station on the same date, the train will start for Kolkata. The officials will return Bangladesh on the 9<sup>th</sup> of April, 2017 by the same train which will leave Kolkata at 08:05 am. The following terms and conditions will be applicable :-

- While on travelling they will be treated as on duty;
- They will draw their pay and allowances in local currency. No part of it should be drawn in foreign currency;
- All the expenses will be borne from the concerned Division.
- They will not be allowed to stay in India more than the approved period .
