Sub: **Debarment against M/S Diesel Impex Incorporated, Canada in participating Public Procurement activities in Bangladesh Railway and Cancellation of Pre-qualification and Enlistment.**

This is to notify all concerned that debarment has been imposed against M/S Diesel Impex Incorporated, 3132 Patrick Crescent, Mississauga, Ontario L5N3G5, Canada, in participating Public Procurement activities in Bangladesh Railway and their Pre-qualification and Enlistment has been cancelled by the Head of the Procuring Entity (HOPE) for the following reasons:

- (i) Presentation of false documents during pre-qualification and enlistment application.
- (ii) Local agent authorization given to M/S Trade Impex, 528/545 Sk Mujib Road (3rd Floor), Dewanhat, Chattogram, but no such company is found in the address.
- (iii) **Non-compliance to after sales warranty service against different contract agreements signed with M/S Diesel Impex Incorporated, 3132 Patrick Crescent, Mississauga, Ontario L5N3G5, Canada.**
- (iv) Non-payment of Bangladesh Railway dues for different MDM(s) & shipping related charges, even after repeated notice for payment.

This is issued in accordance with the Rule-127 of the Public Procurement Rule (PPR), 2008 and this has got approval of the Director General, Bangladesh Railway.
